From Our Chief Executive Officer

Dear Members,

Welcome to your 2016-17 Annual Report.

The team at the Australian Camps Association have spent the past 12 months devoting ourselves to the theme of community, and publications such as this Annual Report really exist to keep the ACA community, of which you are a valued part, up to date on our activities on your behalf throughout the year.

First and foremost amongst those activities was a concentrated effort from me and Steve Hamilton, our Memberships and Preferred Supplier Manager, to personally connect with members from around Australia. Between us we have visited well over 80 member camps spread over every state during the past 12 months in an effort to learn more about your businesses, your needs and your concerns for the future. Thank you to all of those who took time out of their schedules to chat to us and show us around their sites!

These visits were backed up by information received through the **2016 Member Survey**, which told us that two thirds of you considered sales, marketing and competition to be your primary challenge in 2016 heading into 2017.

The information gleaned from these visits, the survey and other avenues such as phone conversations helped us shape the content of the **2017 National Conference**, held in Melbourne in June. Tuning such content to appeal to both emerging leaders and long-time professionals in the camps field proved a challenging task, but post Conference feedback indicated that we got the mix pretty right – as well as giving us some valuable insights to be applied when we commence preparation for the 2019 Conference. The Conference itself was a great success and it certainly supported our community building efforts, with delegates from more than 50 camps across four states attending. It was also a great pleasure to host the gala dinner, during which we were able to announce a new Life Member, Julie Parr of South Australia's Active Education, together with new Southern Cross Awardees David Strickland, Colin Kneebone and Grant McCance. Special recognition was also made of two of our People Outdoors volunteers, Tim McNeill and Tal Harwood, each of whom have volunteered on an incredible 100 + camps! My thanks to all of the ACA staff and Board directors involved in organising this event, but special thanks must go to Jess Hough, our Events and Communications Manager, for her extraordinary efforts pre, during and post Conference and to Gosia and Louise for their assistance throughout the event.

We have completed a staff restructure and with changes to our reporting regimes, along with a real focus on improving our organisational efficiency, our financial position has improved significantly. It has been very satisfying to be able to better our budget forecast and turn a small but handy surplus this FY, which in turn gives us a stable platform for the future and the ability to invest further in member services. Thanks to our Treasurer, Angela Chandler, for her invaluable guidance and support.

There has been no area more challenging, however, than that of our outdoor activity provider arm for people with disabilities – **People Outdoors**. I think that most involved would agree that the rollout of the NDIS has not been especially smooth and I really appreciate the efforts of Heike Fleischmann, our PO Team Leader, in getting to grips with the intricacies of the new system so well. Together with our Senior Program Coordinator, Gosia Barcikowska, the team has delivered our first NDIS funded outdoor programs (whilst continuing to deliver a range of more traditionally funded camps) with great results. There is no doubt, however, that this is an area that will continue to challenge us in the coming financial year as we establish new client bases, program types and financial reporting systems.

While talking of People Outdoors, I'd like to recognise Marnie Broomhall, who left the organisation in the second half of 2016 as a result of a team restructure. Marnie had a real connection with, and devotion to, our campers and we thank her sincerely for her contribution over many years. Finally, we have physically moved from our Keilor Park premises to a new location in a serviced office complex in Preston (still in metropolitan Melbourne). The reasons for the move were many and include better public transport accessibility, improved security, cost reductions in rent / outgoings and last - but by no means least - a physical indicator that the ACA is becoming an ever more professional mainstream organisation. Please do call in and see us if you are ever in Melbourne.


Booking Enquiry Service: One of Our Key Membership Benefits

The ACA receives many enquiries over the year which we sort and send directly to members, a very clear member benefit. This year we have made a number of changes designed to increase these enquiries, including:

- Optimising the positioning of the enquiry button on our website to better suit tablet and mobile
 phone access (this occurred in late September and the impact can clearly be seen in the table below),
- Investing in a Google AdWord campaign to boost enquiry rates in Queensland, South Australia, NSW, Western Australia and Tasmania,
- Improving our Search Engine Optimisation (SEO).

As a result, enquiries have grown by 44% (from 311 to 446) from the previous financial year, including a near doubling of school enquiries (41 in 15/16 to 79 in 16/17). We still have work to do to build enquiries in the non-Victorian states and will continue to develop this in the 17/18 FY.

Table one clearly shows the peaks and troughs of enquiries through the course of the year and show how important it is to be on top of your phones and emails during the January to March period in particular.

In some cases, participation is assisted by our charity, the People Outdoors Fund. All programs are staffed by trained and passionate professionals and volunteers.

People Outdoors programs are hallmarked by a high level of communication with parents/guardians and campers, including personal intake meetings and post program evaluation. Our programs only operate at Australian Camps Association member camps that are accredited with the ATAP program. A Volunteer Perspective- Tim McNeill

Hello,

My name is Tim and I've kindly been given the opportunity to tell my journey at People Outdoors. I guess it all started back in 2001 when I was studying a Certificate IV in Adventure Tourism. We had an excursion to the Outdoor Recreation Centre in Viewbank. Now you wouldn't think Adventure Tourism has much to do with People Outdoors but our course had a big outdoor education component and that is where People Outdoors comes in. After learning more about People Outdoors, it sounded like it was right up my alley. I had already done some volunteer work in disability and love the outdoors so it was a perfect fit. I did my first camp in September 2002. My first People Outdoors camp experience was great and I haven't looked back since.

I have been a part of People Outdoors for 15 years and have seen the program grow and change significantly. Over the years the People Outdoors office has had quite a few homes and the whole reason the program has been so successful for nearly 30 years is because of all the dedicated staff, volunteers, program leaders and of course, the campers. Everyone's enthusiasm and energy is infectious. I have made many great friends over the years and met so many great campers and their families. I have been to so many great campsites and met countless, extremely generous and welcoming camp operators. I have also been very lucky to gain some paid employment at some of the camps.

It was a great honour and privilege for myself and Tal Hardwood to be recognised with an award at the ACA National Conference in June of this year (2017). It was a very humbling experience for me personally. I was so glad to be able to share the experience with Tal as we have been on many camps together. We both wouldn't have made it this far without the support from the awesome People Outdoors staff, fellow volunteers and Program Leaders, campers and campsite operators. Being recognised for my 100th camp in such a way was very special and memorable. I am very grateful to everyone that was involved in keeping the celebrations such a big surprise!

It has been rewarding working with the same campers over a number of years on "Adventure for All" weeklong school holiday camps. It's nice to be able to watch campers grow from year to year and to be requested by their parents to look after their children again. Meeting the campers and their families before camp gives us, volunteers, an opportunity to provide a comfortable and somewhat familiar camp experience for the camper while still challenging them to try new things.

The biggest challenge on camp is trying to modify equipment and activities such as the giant swing, flying fox and canoeing so no matter how physically limited someone may be, everyone can have a go, especially when they really want to! Working with people with a disability in the outdoors, often makes

you think outside the box in order to modify and adjust an activity so that campers can safely participate. It's great to see a camper going home stoked about what they did on camp and then able to share their experiences and stories with their families!

I have had many memories from camp ranging from dressing up in costumes, avoiding leeches on bushwalks, delivering a baby wombat on the side of a road and capsizing almost every canoe I have been on with my camper. People Outdoors have also given me an opportunity to volunteer on an interstate camp in Sydney and support campers at special events such as the Great Victorian Bike Ride and snow camps.

I have been volunteering at People Outdoors for many years and the main thing that keeps me coming back is the fun and enjoyment that each camp brings. I enjoy the challenge of working with new and returning campers and those with challenging behaviours. It is nice to know that our families and carers can get a small break, while their campers are having a great time. As a volunteer I have made many life-long friends and have met some extraordinary people. Spending time outdoors and being able to see some beautiful parts of our state is a bonus!




ACA National Conference

From the Treasurer

Financial Results for the year ended 30th June 2017

I have pleasure in presenting the audited annual accounts for the Australian Camps Association (ACA) for the year ended 30th June 2017. I have really enjoyed my first year as Treasurer for ACA and appreciate the time and effort CEO Pete Griffiths has put into guiding me on the ACA's operations.

This year has been another of transition and challenge. I am happy to report a financial year profit of \$57,780 which is \$12,000 better than budgeted for at the beginning of this year.

The first stage of transition to the National Disability Insurance Scheme (NDIS) has resulted in significant changes for operations of People Outdoors and the financial uncertainties associated with this have been difficult to manage and accurately budget for. Pete and the People Outdoors team have done a terrific job in an unpredictable financial environment in moving many campers across to NDIS plans and running our first NDIS programs. An unforeseen funding reduction in June 2017 of \$50,000 in DHHS funding has lead us to be more conservative in budget forecasts for 2017-18 when we anticipate losing a further \$230,000 at some point in the financial year. Despite this, we continue to be optimistic that People Outdoors will have a bright future in the post NDIS environment in the longer-term future.

Pete and his staff have continued to review expenditure and remove costs from our operations, and to ensure everything we do is contributing to achieving our strategic objectives. The move to a new office premises in June 2017 will generate savings from operational efficiencies in 2017-2018. We have also seen savings this year on salaries and have transferred some wage costs so they are absorbed by grant programs.

We have expended grant funding of almost \$152,000 from our three major grants, Supporting Victorian Sport and Recreation, Outdoor Sector Development and Removing Barriers to Participation, in 2016 -17. Further unspent funding of around \$33,000 from our Outdoor Sector Development grant will be carried over into 2017-18. These funding opportunities allow us to meet many of the strategic success factors outlined in the ACA Strategic Plan and it is important we continue to deliver and meet our grant reporting obligations.

We have seen a great year for ACA membership, with 242 members and an additional \$5,000 over budget from new membership fees. Sustained work with members and preferred suppliers by Membership Manager, Steve Hamilton, has led to a 20% increase in rebates from preferred suppliers (an additional \$17,000 in revenue). A terrific National Conference supported by good industry attendance also netted a return of almost \$15,000. I encourage the ACA to continue its focus on generating revenue outside of People Outdoors as this will be critical to maintaining ongoing financial sustainability and a high level of member services.

As at 30 June 2017, our Balance Sheet showed a positive Members Equity position of \$179,541 and I am comfortable the ACA currently has sufficient cash reserves to meet all recognised financial liabilities.

I move that members receive and note the financial statements of the Australian Camps Association for the Year ended 30th June 2017.
