## **From Our President**

It is often said that the only certainty in life is that things will change!

Well 2015/16 has indeed been a year of significant change for the members, Board and staff of the ACA. Although some of these changes have been beyond our control, others have been initiated by the Board. In this environment of pro-actively initiating change, whilst at the same time responding to externally imposed change, I acknowledge the dedication and commitment of the ACA staff and my fellow Board members. The professional way in which our team has continued to perform is noteworthy.

#### **Board Membership**

Throughout this year the Board has instigated the new Constitutional requirements for Board membership. This has entailed moving from 11 elected Board members, to seven elected Board members and between two and four appointed members.

As part of this transition the Board reluctantly accepted a resignation from our longest serving Board Member and Treasurer Bill Oakley (OAM and ACA Life Member). Bill's service to the camping sector and the ACA, both locally and internationally, has spanned many decades and his wisdom and dedication has been outstanding.

The second Board member who resigned through this period was Daniel Findley. Although Daniel was a Board Member for a short period, his professional approach, particularly regarding HR matters and governance, was greatly appreciated. We wish Daniel well in his next adventure.

Towards establishing a Board more highly skilled across a very diverse range of requirements, a successful Board Member recruitment was conducted early 2016. This process has resulted in the following Board member appointments:

I would like to thank these new Board members for their willingness to serve the ACA and already they are making a significant contribution.

#### Staffing

At relatively short notice and most unexpectedly, late in 2015 the Board received the resignation of our long serving CEO David Petherick. David's service to the camping sector across nearly a decade has been acknowledged elsewhere, however at this point I must acknowledge the tireless and enthusiastic effort David contributed. He joined the ACA as CEO at a point when the future was particularly precarious and through his great passion and personality he was able to set the ACA on a course of growth and sustainability.

Due to several strategic decisions mainly around the NDIS and People Outdoors, the Board made an initial interim CEO appointment. Pete Griffiths very ably filled this three month term and has subsequently taken up the role of CEO. I am very appreciative of Pete's willingness to guide the ACA through a somewhat difficult transition and look forward to him guiding the ACA in the future. Thanks Pete!

Throughout this transition the small team of staff has continued to operate most professionally and have been absolutely supportive of the Board. A big thankyou to Jess, Stephen, Marnie, Heike, Louise and Gosia.

This year has again seen the ACA, through our staff and our members, make a significant contribution to the continuing growth and development of the camping and outdoors sector across Australia and abroad.

Some of the more noteworthy achievements this past year include:

#### **Member Services**

The Board has re-cast the strategic priorities for the next three to five years and at the top of these priorities is member services. Whilst we accept that part of the role for an association such as the ACA is the broader industry development tasks, a primary purpose is services that directly add value for our members.

Pete and the team have been working hard on re-energising several aspects around member services including the group purchasing/preferred supplier benefits scheme, training activities, Outdoor Business Online and support resources to name just a few.

#### Training

In line with increasing member satisfaction, the ACA has continued to ramp up the provision of training opportunities for camping professionals. Once again a big thankyou to the training sub-committee convened by Marie Feutrill for all their work in this space. A great training schedule is in place and many members are benefiting from camping specific training events.

#### **People Outdoors and NDIS Transition**

The enormous challenge of transitioning the block funded People Outdoors programs to the new National Disability Insurance Scheme has occupied a significant effort this year. The Board has considered all the known implications of these changes and we anticipate an ongoing viable engagement in this important work. Led by a great team of staff, our team of volunteers has again been committed to delivering more than 40 programs for people with special needs. This important work provides great experiences for campers and respite for families. Well done to the P.O. team.

Lastly, a big thankyou to my fellow Board members, who along with already busy work and family lives find the time to dedicate to ensuring the ACA is the best it can be.

## **From Our Chief Executive Officer**

Dear All,

This Annual Report marks the first for me as CEO after a number of years serving on the ACA Board. Before I make my remarks, I must pay my respects to the outgoing CEO, David Petherick, who left the organisation in November 2015 after ten years of service to take up a role with the National Disability Insurance Agency (NDIA).

My first year in the post has been somewhat hectic as we grappled with the intricacies of the National Disability Insurance Scheme (NDIS) and its impact on the activities of People Outdoors, the arm of the ACA that delivers outdoor experiences to people with disabilities. The introduction of the NDIS has been challenging in many ways, not least of which is the need for People Outdoors to promote and market itself in a suddenly highly competitive market. This process has been an invaluable one, however, as it has helped the team really understand and focus on person centred delivery and the need to be really clear about the wonderful benefits, social, physical and emotional, that our campers enjoy as a result of their experience in the outdoors.

Our Five Year Strategic and Business Plan underwent its annual review at the Board's Retreat in March. The clarity and refinement of thinking that resulted from this review has been greatly useful to me as we drive the ACA's Objective Priorities, which are to:

- Continue to develop People Outdoors
- Advocate on behalf of, and facilitate services for, members on a national basis
- Develop ACA product and services that support member businesses
- Champion standards and accreditation
- Improve Board function and governance

In a nutshell, my work revolves around helping to improve the Camp experience and support the business of camps on behalf of all members, no matter what state of origin or business structure.

One essential element of this is our on line enquiry function (Booking Enquiry Service) which collates all camp enquiries through our website and disperses them to member camps. A total of 311 enquiries were generated on your behalf during the 2015/16 financial year (up from 290 in the 2014/15 FY), including 41 from schools.

As you will read in the Treasurer's Report, we have had a challenging year financially, due in part to changes to our accounting and reporting framework. We have put measures in place to address this and unfortuately as a result we have not been able to continue the employment of one of our People Outdoors staff members, Jade de Valle. I would like to thank Jade for her contributions to the work of People Outdoors and we hope to continue to see her on future programs in the field.

Finally, I would like to acknowledge the support of Jess, Steve, Heike, Gosia, Marnie and Louise in supporting me in my new role. Thank you for your patience and willingness to pitch in as we undergo this period of change.

## **Booking Enquiry Service: One of Our Key Membership Benefits**


Every year the ACA generates hundreds of online booking enquiries through our website which are then forwarded on to members. One of our key internal performance indicators is the quality, number and spread of these enquiries across Australia. It is gratifying to see that enquiries for the 2015/16 financial year increased by 7% over the previous period and that we were able to deliver enquiries for camps throughout the country.

Enquiries from community groups make up 85% of the total received, which indicates the great interest people have in the camping experience and the enormous diversity of campers we see - everyone from family reunions to faith groups to sporting and special interest clubs - even the occassional wedding.

The data spread in the graph below also clearly illustrates the ebb and flow of interest across the year, with a clear peak of enquiries in the January/February period and school enquiries peaking at the end of term one.

In some cases, participation is assisted by our charity, the People Outdoors Fund. All programs are staffed by trained and passionate professionals and volunteers.

People Outdoors programs are hallmarked by a high level of communication with parents/guardians and campers, including personal pre camp home visits and post program evaluation. Our programs only operate at Australian Camps Association member camps that are accredited with the ATAP program. People Outdoors programs are all about fun, personal development, social connection and enjoying the great outdoors.

## **A Volunteer Perspective- Ann Vidler**

Hello my name is Ann and this is the story of my People Outdoors journey.

My People Outdoors journey began when I was studying a Certificate IV in Disability at the Kangan Institute. Whilst completing my work placements I was able to demonstrate the necessary skills and knowledge in both a simulated environment on Kangan Broadmeadows and Moonee Ponds campuses, also in a work environment. It was during one of Kangan's incursion days during class when we were introduced to Heike, the representative from People Outdoors.

I was very impressed with the way in which Heike explained to our class the adventures that People Outdoors provided for individuals with a disability within the local and broader communities. She spoke with such affection and dedication that I was inspired to sign up and add People Outdoors as a second placement option. I was sure that this would offer a rewarding experience for both me and the participants who attend the "Adventure for All" activities.

At my Induction with People Outdoors I was given a Volunteer's Handbook, which was a great reference guide for my first weekend camp as I was unsure if I would be able to remember all of the People Outdoors required policy and procedures while providing support for my designated camper.

The Camper Profile and the detailed volunteer job description, together with attending a home visit gave me the

information on the required levels of support that I needed to be providing while on "Adventure for all" Camps.

My first camp gave me the opportunity to use transferable skills I gained as a parent, as a person with dual qualifications in Aged Care and Home and Community Care and as a student enrolled in a Certificate IV in Disability to provide support to People Outdoors campers.

I was provided excellent assistance from the Keilor Park People Outdoors office staff and exceptional guidance from the Program Leader throughout the time spent on that weekend camp. This gave me the confidence to successfully complete all the required tasks.

I have since attended approximately fifteen People Outdoors Programs which include eleven camps and four day activities. During this time I gained the necessary experience to become a Program Leader on day activities and school holiday and weekend camps.

People Outdoors camps provide experiences that helps participants, volunteers and Program Leaders with a deeper understanding of how the world works. They teach discipline, teamwork and leadership while also providing people with a disability with social connections through flexible inclusive activities. Each program is designed to meet each camper's needs, goals and aspirations. The camps and day activities focus on participant camper's potential ability and not on the limitations that arise from the many types of diagnosed physical and intellectual impairments.

A participant may face personal challenges while on camp however careful consideration is taken to assess all risk levels to provide safe participation in any program or day activity.

Activities which may include swimming, rope courses, Flying Fox, Giant Swing, canoeing, cooking, campfires, surfing, beach activities , bush adventures and educational learning within the local community - all of which I have had the privilege to experience as a member of the People Outdoors Team.

I have seen firsthand how each activity can improve socialization and change expectations, attitudes and behaviors while having a significant positive impact on each individual who is in attendance.

In my opinion People Outdoors vision provides holistic inclusive opportunities that empower campers, families, volunteers, the community and all staff members and in doing so improves the quality of life for all.

## From the Treasurer

Financial Results for the year ended 30th June 2016

I have pleasure in presenting the audited annual accounts for the Australian Camps Association for the year ended 30th June 2016. This will be my final Treasurer's Report for ACA as I have retired as Treasurer and from the ACA Board after many years.

This year has been a year of transition and challenge. After many years of daily commuting from Geelong to Melbourne, long serving CEO David Petherick resigned to take up a position with the National Disability Insurance Agency much nearer to home. I want to acknowledge here the support I have received from David and the staff at ACA over many years in my role as Treasurer.

With the strong support of new CEO Pete Griffiths we have undertaken a review of the finances of ACA during this past year. This was prompted by the need for us to ensure we deal appropriately with grants and with the liabilities implied by our acceptance of grants. Much grant income is received in financial years which are different from the year in which the work for which the grant was made is undertaken. Also, the progressive implementation of the National Disability Insurance Scheme (NDIS) over the coming three or four years will generate significant changes to the operations and finances of People Outdoors.

In previous Treasurer's Reports I have expressed concern at the heavy reliance the ACA has on the funds generated by People Outdoors. As I write this it is not entirely clear what impact the NDIS will have on People Outdoors and ACA operations, however we are optimistic that People Outdoors will have a bright future in the post NDIS environment. The need to confront this change, along with assistance provided by Government to assess, restructure and reorganise to cope with the transition, has caused us to review our operations.

This year's results report a loss of \$86,493 which is substantial and is about \$50,000 greater than the loss we budgeted for at the beginning of this year. The Board and I have been aware for some months that this would be the likely result for the year. Most of this increase relates to a number of one-off items relating making adjustments to our take up of income to align it with the year in which the services are provided for which the income is received. I am confident that our present balance sheet and accounts accurately reflect our position.

Besides making these changes Pete Griffiths and his staff have addressed the need to constantly review expenditure and to remove costs from our operations, and to ensure everything we do is contributing to achieving our strategic objectives. As a result the 2016/17 budget gives us the confidence that this year will generate a significant positive result. For the longer term, our historic reliance on the income generated by People Outdoors remains unwise, particularly in view of the uncertainties brought about by the introduction of the NDIS. I urge the CEO and Board to continue to actively explore and pursue avenues to increase and diversify the sources of income to ACA.

Although retired from the ACA Board I continue to take a keen interest in the work of ACA, and I wish incoming Treasurer Angela Chandler every success in what can be a challenging role. I move that members receive and note the financial statements of the Australian Camps Association for the Year ended 30th June 2016.


