

This year has again seen the ACA, through our staff and Led by a great team of staff, our team of over 200 our members, make a significant contribution to the continuing growth and development of the camping and outdoors sector

across Australia and abroad. Some of the more noteworthy achievements this past year include:

International Engagement

The International Camping Congress - Turkey October

This congress saw the largest ever contingent of more than 20 Aussies attend. Furthermore, there were several Australians engaged in the conduct of workshops, preconference events and presentations. Once again it was a wonderful opportunity to network on the global camping stage.

Inaugural China Camps Education Conference - Beijing April 2015

Again the ACA and our members were front and center at this event. Four Australian trainers/presenters plus several other Australian delegates waved the Aussie flag. The growing opportunities to engage with the Chinese/Asian market continue to be explored.

Camping Fellowship

The ACA continues to be very involved with each of these organisations and the tireless work of Bill Oakley is here acknowledged. Bill has travelled many thousands of miles, much at his own cost, to represent us all. Thanks

Training

The ACA Board has determined to increase the provision of training opportunities for camping professionals. A big thankyou to the training sub-committee convened by Maree Feutril for all their work in this space. Training events this year have been well attended and feedback has been excellent. People Outdoors

Research Collaborations

The ACA has again been very engaged in two significant ongoing research projects. The Outdoor Youth Programs Research Alliance, (investigating the benefits of camp programs) and the UPLOADS accident and injury research project. This is a very important peace of work and results and reports will begin to flow soon.

As usual there is a multitude of other work undertaken by the ACA on behalf of our members and the sector. The list is too long to provide detail here, however only through member engagement and feedback will the services of our association stay relevant to your needs. Treasurer's Report

I am pleased to present the annual financial report and accounts for the ACA for the year ended 30th June 2015. This year we returned to "the black", with a surplus of almost \$52,000, more than recovering the deficit of the previous year, and bringing our retained earnings to over \$200,000. For a small organisation like ours, it is important to maintain a healthy level of reserves to help us ride out rough periods, and to give us the confidence to embark upon new ventures. This level of reserves is still only about 20% of our annual turnover. I believe we need to get to a level of approximately 50% of our annual turnover to feel comfortable. So while this year's result is a good step in the right direction, we still have some way to go.

This result has been produced from a slight level of increase in revenue and a considerable amount of "belt tightening" in the expense area, Our CEO David Petherick, and his staff have continued to be able to do more with less, and they are to be congratulated again on a very frugal operation. However the long term financial security of ACA can only come from generating increased revenue from a variety of different sources. Our surplus has come in part from a reduction in our staff. This limits our capacity to explore, evaluate and try new ways of generating revenue. We remain heavily reliant upon People Outdoors as the principal source of income. The introduction of the National Disability Insurance Scheme over the next few years presents both opportunity and threat to People Outdoors. I believe it is high time we pursue options to add new sources of revenue for ACA.

The new ACA Constitution means that the number of Board members who are elected is reduced to give the Board the opportunity to appoint some Board members with skills and expertise which it is considered we need on the Board. I retire at this Annual General Meeting, and as there are no vacancies for elected positions I will not be standing for election. After being on the Boards of ACA, and CAV before it, for most of the last thirty years; and with the Board actively reviewing its strategic direction, perhaps this is a good time to step back and make way for some newer and younger members. It has been a pleasure and an honour to be on the Board of ACA, and I hope I will still have the opportunity to contribute to the work of ACA in the background.

Finally a thank you to all of the ACA Members I have had the great pleasure to meet over the years. I have appreciated your passion and your welcoming attitude. I was overwhelmed and touched by your messages of support when I announced my resignation.
